If you want to build a lateral drain to connect to a public sewer which is located outside your new property boundary, you will probably need to apply for an adoption agreement with us before any installation work begins, in line with the Water Industry Act 1991. Sewers must comply with the mandatory standards set out in The Welsh Ministers Standards for Gravity Foul Sewers and Lateral Drains.

Adopting proposed sewerage systems - Dwr Cymru Welsh Water

These standards aim to ensure all new sewers and lateral drains are built to a suitable standard and 'adopted' by Welsh Water, who will then maintain and repair them. The Supplementary Transfer is necessary to transfer sewers and lateral drains, constructed between 1 July 2011 and the introduction of the new construction standards on 1 October 2012, from developers and property owners to Welsh Water.

On 1 July 2011 the Water Industry (Schemes for Adoption of Private Sewers) Regulations 2011 came into force. The Regulations se triggered the overnight transfer of gravity private sewers and lateral drains to sewerage undertakers across Wales and England on 1 October 2011. The transfer removed the

The legislation in Wales and for Welsh water companies differs from those applicable for English companies and consequently, the arrangements for sewer adoption in England and Wales are now different.
