About 2 in 10 prisoners and 3 in 10 jail inmates reported having a cognitive disability, the most common reported disability in each population. Social Security Disability Insurance (SSDI) and Supplemental Security Income (SSI) payments generally aren't payable for months that you're confined to a jail, prison, or certain other public institutions for committing a crime. You're not automatically eligible for Social Security or SSI payments after your release.

An individual released from incarceration may be eligible for Supplemental Security Income benefits if they are 65 or older, are blind, or have a disability and have little or no income and resources. Overrepresentation of Cognitive Disabilities According to a Bureau of Justice Statistics report, 30% of jail inmates reported having a cognitive disability—far higher than among the general public, where less than 5% of people self-report a cognitive disability.

The Americans with Disabilities Act (ADA) and Section 504 of the Rehabilitation Act of 1973 (Section 504) are federal laws that protect people with disabilities, including people who are incarcerated, from discrimination on the basis of their disability. This means that jails and prisons may not discriminate against you because of your disability.

THE AMERICANS WITH DISABILITIES ACT IN JAIL PRISON

For those inmates who were already receiving Social Security Disability benefits, conviction of a crime and incarceration for more than 30 continuous days will result in suspension of benefits (though they can be reinstated the month following the month of release).

Disability Compensation VA disability compensation payments are reduced if a Veteran is convicted of a felony and imprisoned for more than 60 days. Veterans rated 20 percent or more are limited to the 10 percent disability rate. For a Veteran whose disability rating is 10 percent, the payment is reduced by one-half.
