Passive euthanasia involves withholding treatment with the intent to cause death. Physician assisted suicide, "PAS", is a type of voluntary euthanasia in which a doctor either intentionally provides information to a patient about how to commit suicide, or prescribes the means that allow the patient to commit suicide.
