Secure Pool by Boarding To board a pool, use 2x6s to build a box that is larger than the pool, extending onto the ledges all around the pool. Then nail "joists" inside the box, 16 inches on center, full length of the pool. Next staple 6 mil plastic sheeting over the entire wood structure you've built.
