Methadone maintenance treatment (MMT) is considered to be the effective opioid substitution treatment for most opioid-dependent people wanting to minimise harms associated with their illicit opioid use. MMT aims to minimise withdrawal symptoms, reduce opioid drug craving and reduce euphoric effects of injected opioids.

Opioid Substitution Therapy (OST) is another important element of HIV prevention among IDUs. The process of initiating OST within the HIV programme began during NACP III, and a number of quality assurance mechanisms were built in the programme. Newer models of OST delivery were also tested and found to be equally feasible.

Pharmacologic treatment with methadone and buprenorphine has been shown to be effective at retaining people in treatment programs, decreasing illicit opioid use, decreasing rates of hepatitis B, and reducing all cause and overdose mortality.
